The meeting was called to order at 8:02 a.m. with Chair Woo presiding.

Item 4: Public Comment

- ◆ No public comments were received.

Item 5: Approval of Minutes for June 5, 2025

Upon consideration thereof, it was moved by Commissioner Lee, seconded by Commissioner Coleman, and unanimously carried (3-0) to approve the minutes of the Commission meeting held on June 5, 2025.

Chair Woo indicated that the motion was approved by a 3-0 vote

Item 6: Relocation of Commission Meetings – Resolution No. 08-25-037

- ◆ Due to construction in the meeting room at Walnut Valley Water District, as that location was designated by prior resolution, relocation to Rowland Water District of the next several Commission meetings that would otherwise be held at Walnut Valley Water District was necessary; and approval of the change of location to Rowland Water District was requested.

Upon consideration thereof, it was moved by Commissioner Lee, seconded by Commissioner Coleman, and unanimously carried (3-0), by roll call vote to approve Resolution No. 08-25-037 approving the relocation of the August 7, October 2, and December 11, 2025 meetings to the Rowland Water District.

Chair Woo indicated that the motion was approved by a roll call vote of 3-0

Item 7: PBWA Legislative Activities

A. SB 72 and CA Water for All Campaign Update

- ◆ Mr. Macias provided the Commission with an update on the item, which was placed on suspense file of the Assembly Appropriations Committee, to be heard in two weeks to possibly advance from the Assembly Appropriations Committee.

B. Approve Addendum to Reeb Government Relations Lobbying Contract

- ◆ An addendum to the current agreement was requested to include Pico Water District. With the addition of a fourth member to the agreement, the cost per agency decreased from \$2,250 to \$2,000 per month for 2025.
- ◆ The annual cost of \$6,500 per month for 2025, and \$6,750 per month for 2026 is included in the proposed amendment to the contract.

Upon consideration thereof, it was moved by Commissioner Lee, seconded by Commissioner Coleman, and unanimously carried (3-0) to approve the addendum with Reeb Government Relations to include Pico Water District at the annual cost of \$6,500 per month for 2025, and \$6,750 per month for 2026.

Chair Woo indicated that the motion was approved by a 3-0 vote

Item 8: Regional Water Supply Reliability Program

A. Puente Basin Groundwater Management Plan

- ◆ Mr. Macias reported that West Yost is evaluating cost alternatives and that the data request process is ongoing. Additional information on the Puente Basin Groundwater Management Plan will be presented at the December meeting.

B. California Domestic Water Company

- ◆ Mr. Coleman reported that the Cal Domestic project is currently operating with a single pump, expected to continue through July. Flow may increase to two or three pumps once a water quality issue at Cal. Domestic is resolved, with three pumps anticipated through the winter.

C. Central Basin

- ◆ Mr. Coleman reported ongoing discussions with Pico Water District and the City of Whittier on intertie designs and a potential partnership. These efforts represent a key step in moving the project forward.

D. Pomona Basin Regional Groundwater Project

- ◆ Mr. Macias stated that both wells are operational. The Three Valleys Municipal Water District permit is pending, and the state has shown interest in exploring potential treatment options for the site.

E. Covina Valley Partner Project

- ◆ The Commissioners were updated that Covina Irrigating Company changed its name to Covina Valley Water Company and its merger with Valencia Heights Water Company is nearing completion.

- ◆ General Counsel Ciampa provided a brief legislative report.

- Mr. Ciampa provided the closed session report that the Commission unanimously ratified a 465-acre-foot lease of Central Basin Allowed Pumping Allocation to Montebello Land & Water Company for the 2024-25 water year at a price of \$125 per acre-foot.

RE: Consider Award of Third Amendment to Professional Consultant Services Agreement with West Yost for Phase 2 - Part 3 of the Puente Basin Groundwater Management Plan

Recommendation

That the Board of Commissioners authorize the Administrative Officer to execute the Third Amendment to Professional Consultant Services Agreement with West Yost for Phase 2 - Part 3 of the Puente Basin Groundwater Management for a total not-to-exceed \$74,132.

Background

In 2022, Puente Basin Water Agency (Agency) contracted with West Yost to develop a Groundwater Management Plan (GMP) to enhance the management of the Puente Basin beyond the execution of the Puente Basin Judgement (Judgement) and Puente Narrows Agreement. PBWA desires to maximize the beneficial use of the Puente Basin and thereby decrease dependence on imported water supplies. The GMP is being developed in three phases:

- Phase 1 – Describe the State of the Puente Basin and Establish GMP Goals.
- Phase 2 – Evaluate Alternatives for Basin Management.
- Phase 3 – Prepare GMP and Implementation Plan.

West Yost will perform the scope of services to perform Phase 2 – Part 3 described in the original agreement on a time-and-expenses basis, at the billing rates set forth in West Yost's attached 2024 and 2025 Billing Rate Schedule, with a not-to-exceed budget of \$74,132. Per the amended Cost Sharing Agreement with PBWA and City of Industry (City), PBWA will pay two-thirds (2/3) of such costs and the City will pay one-third (1/3) of such costs.

THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT

This Third Amendment to Professional Consultant Services Agreement (the "Amendment") is made this 2nd day of October, 2025 by and between Puente Basin Water Agency, a public corporation organized and existing under the provisions of the California Government Code, hereinafter referred to as "Agency," and West Yost, hereinafter referred to as "Consultant," with respect to the following facts:

RECITALS

A. Agency and Consultant entered into a Professional Consultant Services Agreement dated May 25, 2022 (the "Agreement") under which Consultant provided services to Agency in connection with Phase 1 of the development of a Groundwater Management Plan for the Puente Basin (the "GMP").

B. The parties executed an initial amendment to the Agreement, with the last signature to that amendment dated October 4, 2022, and a second amendment to the Agreement dated April 4, 2024.

C. Consultant has completed the services related to preparing Phase 1 of the GMP and Phase 2 – Part 1 of the GMP and Agency and Consultant now desire to amend the Agreement to address the services Consultant will provide in connection with Phase 2 – Part 3 of the GMP.

D. Agency and Consultant by this Amendment set forth the revisions to the Agreement necessary to memorialize the terms and conditions under which Consultant will render the services for Phase 2 – Part 3 of the GMP.

NOW, THEREFORE, for good and valuable consideration, the adequacy and receipt of which is acknowledged, Agency and Consultant agree as follows.

1. A new Recital 2.5 is added to the Agreement to read as follows:

"2.5 Consultant has completed the Phase 1 and Phase 2 – Part 1 services and Agency and Consultant desire to amend this Agreement to address the Phase 2 – Part 3 services related to the GMP, with the required professional services for those services more specifically delineated in the Scope of Work attached hereto as Exhibit C, subject to the terms and conditions of this Agreement, at a cost not to exceed \$74,132."

2. A new sentence is added to the end of Section 3.1 of the Agreement to read as follows:

"3.1 [original provisions to remain] Services related to Phase 2 – Part 3 of the development of the GMP will be performed under the terms of this Agreement as specified in the "5.0 - Scope of Services to Perform Phase 2 – Part 3" starting on page 32 of Consultant's Technical Memorandum No. 3 – Part 1 & 2 – Puente Basin Water Agency, dated June 18, 2025, as attached hereto as Exhibit C."

3. In Section 3.4, the reference to Exhibit A is replaced by a reference to Exhibit C.
4. Section 3.5 is deleted and is replaced by the following:

“Agency shall pay Consultant the compensation specified in Section 2.4, above, at the time and manner set forth in Exhibit A to the Agreement.”

5. Section 3.5 is deleted and is replaced by the following:

“To the extent there is any conflict or inconsistency between the terms of this Agreement and the terms of Consultant’s proposals, as set forth on Exhibits A, B or C, as applicable, the terms of this Agreement shall govern.”

6. Except as amended by Paragraphs 1 through 5, above, the Agreement, as previously amended, shall remain in full force and effect.
